The signatory of the applications will:

Certify that he/she is a citizen of the United States; has never been convicted of a felony or misdemeanor; detail the particular business, trade or occupation for which the permit is required; the manners and/or means of conveyance in which the said business or trade shall be conducted; the name of the person(s) or the residence of the person(s) composing any such firm, or the principal place of business of any such corporation, and the name of the officer in the corporation upon whom process or any other legal notice may be served.

Issuance of Permit:

Upon the filing of the application, as provided, the Village Clerk-Treasurer, upon approval of application issue to the applicant, a permit signed by the Village Clerk. Except as herein provided, no permit shall be refused except for a specific reason and for the protection of the public safety, health, morals or general welfare. A permit shall not be assignable, an unauthorized use thereof, either by a holder of such permit or by any other person, shall be deemed to be a violation.

Fees:

The permit fee to peddlers or solicitors shall be as follows:

One (1) day is \$15.00; one (1) month is \$30.00; six(6) months is \$75.00; and one (1) year is \$150.00. No fee shall be required of a disabled veteran whose disability is proven, to the satisfaction of the Mayor, to be combat related.

Revocation of Permit:

The Mayor may, at any time for a violation of this Permit or any other ordinance or any law, revoke said Permit. When a Permit is revoked, no refund of any unearned portion of the license fee shall be made. Notice of such revocation and the reason(s) therefore, shall be served and /or mailed upon the person named in the application or by mailing the same to the name and address given on the application, and a copy of such notice shall be filed with the Village Clerk.

Restrictions on Permit:

A licensed hawker, peddler or solicitor shall:

- 1.) Not falsely or fraudulently misrepresent the quantity or quality of any article offered for sale or offer for sale any unwholesome, tainted or diseased provisions or merchandise.
- 2.) Keep the vehicles and receptacles used by him in a clean and sanitary condition and the foodstuffs and edibles offered for sale well covered and protected from dirt, dust and insects.
- 3.) Not stand or permit the vehicle used by him to stand in one place in any public street or place for more than 10 minutes or in front of any premises for any time if the owner of or lessee of the ground floor thereof objects.
- 4.) Not sell any confectionery or ice cream within 250 feet of any school between the hours of 8:00 AM and 4:00PM on school days.
- 5.) Not permit any vehicle used by him to stop or remain on any crosswalk.
- 6.) Unless otherwise noted this permit cannot be used during Village sponsored functions in and around the Riverfront Park area, for example, APAC performances and the Street Festival.

Penalties for offenses:

Any person, firm or corporation who shall violate any of the provisions of this Permit shall, upon conviction, be punishable by a fine of not more than \$250.00 or by imprisonment for not more than 15 day, or both.

Exempt Organizations to give Notice of Intent:

Any organization exempt under Internal Revenue Code (IRS) shall, prior to soliciting funds, notify the Village Clerk of its intention to solicit funds. Village Clerk shall issue, at no cost, a Certificate of Compliance with this Permit.
