VILLAGE OF ATHENS BOARD MEETING MINUTES - February 8, 2023

PLEDGE TO THE FLAG

PRESENT: Mayor Amy Serrago, Trustee Gail Lasher, Trustee Josh Lipsman and Trustee Rob

ABSENT: Trustee Stephan Bradicich

Clerk-Treasurer Mary Jo Wynne was present for the purpose of taking Minutes.

Meeting held at 6:30 PM at the Athens Firehouse.

DEPARTMENT HEADS

1. Water & Sewer

Joe Myers, representing Northdome, attended the meeting and provided a monthly report of activity at the WFP and the WWTP's for the Village Board.

2. Department of Public Works

Director Christopher Sprague informed the VB that they have been working on hydrant maintenance, replacing some road signs and working with Northdome at the Water Filtration Plant.

The Director also gave the VB information on the possibility of purchasing:

- A new loader to replace the Backhoe
- A new chipper to be used when they take down trees
- Pressure washer
- Discussed the possibility of purchasing new lawnmowers and hiring part time employees in order to mow lawns in the village as opposed to going out to bid every year. It may be less expensive in the long run.

3. Athens Volunteer Fire Department

Fire Chief Wayne Butterworth provided the VB with a list of items that they overlooked and would like to have for the new firetruck. They also need to have an answer from the VB by tomorrow. Due to the fact that their equipment budget line item is over-expended they would like the VB to approve spending \$2441.00 from misc. expenses and \$1963.00 from the buildings and grounds line item for the requested equipment.

A MOTION was made by Trustee lipsman, seconded by Trustee Scott, all in favor, to expend \$2441.00 in the misc exp line item to pay for requested equipment and;

A MOTION was made by Trustee Lipsman, seconded by Trustee Scott, all in favor, to expend \$1963.00 from buildings and grounds appropriation for requested equipment.

Asst. Chief John Grecco informed the VB that the Fire Department received a \$50,000.00 grant from Senator Henchey's Office to be used on the dive team. It is a reimbursable grant in that the village purchases the items and then gets reimbursed later after providing proof of payment.

- 5. Code Enforcement Sergeant Ruso attended the meeting and provided a report for the police department and code enforcement.

The Mayor stated that she appreciates them bringing this before the VB but she cannot recommend that as a VB, without review of both sides of the issue, take a stand in opposition to this. She also noted that this project is in the Town of Athens.
